2023 CPU Chinese Government Scholarship

- Chinese University Program

Chinese Government Scholarship — Chinese University Program

Program is established by the Ministry of Education of China (hereinafter referred to as MOE), aiming to support designated Chinese universities to enroll outstanding international students for graduate studies in China.

I Basic Information and Duration of the Scholarships

- 1. Coverage of the scholarship:
- Tuition waiver
- Accommodation: free university dormitory; CPU will accommodate scholarship students in a university dormitory (twin room).
- Stipend:

Master students: CNY 3,000 per month;

Doctoral students: CNY 3,500 per month.

*Within the scholarship duration, registered scholarship students will receive their stipend from CPU month by month.

Students registering before the 15th of the month (the 15th included) will receive the full stipend of that month. Those who register after the 15th of the month will receive half stipend of that month.

If a registered student stays out of China for more than 15 days (school holidays excluded), his stipend will be stopped during his leaving.

Graduating students will receive stipend until half month after the graduation date.

*How stipend will be given is decided by China Scholarship Council under epidemic situation.

2. Categories of Applicants and Duration of Scholarship

Categories of Applicants Master's Degree Students	Duration of Scholarship 3 academic years

I Qualification of Applicants

1.Applicants must be non-Chinese nationals, in good health and willing to

comply with Chinese laws and the regulations of CPU;

2. Education background and age limit:

- be an academically excellent holder of a Bachelor's degree or its equivalent under the age of 35 when applying for a Master's program;
- be an academically excellent holder of a Master's degree or its equivalent under the age of 40 when applying for a doctoral program;
- 3.Language proficiency requirements:

Chinese-taught programs applicants need to submit HSK 4 certificates; English-taught programs applicants need to submit English proficiency certificate: TOEFL: no less than 90; IELTS: no less than 6.5;

*Native English speakers are exempted;

*Applicants who obtained their highest diploma taught in English can provide a certificate of English instruction instead of IELTS or TOEFL certificate.

III Choices of Specialties

China Pharmaceutical University offers 31master's degree programs and 17 doctoral programs. For more specific information, please check the List of programs on our website. (international.cpu.edu.cn)

Graduate program applicants are required to contact their prospective supervisors prior to application and to enclose in their application package the provisional acceptance letter written by those supervisors.

IV Application Materials

1.Passport information page. The applicant shall submit a clear scanned copy of the information page of his/her passport that will not expire on or before June 1, 2024;

2. Diploma and certificate of highest education (notarized photocopy). The applicant who is a current university student shall submit the certificate of expected graduation or student status issued by his/her university. Please resubmit the notarized copy of highest diploma before registration;

3. Academic transcripts. Transcripts in langauges other than Chinese or English shall be attached with notarized translations in Chinese or English; 4.Certificate of language proficiency. When applying for a Chinese-taught program, the applicant shall provide a valid HSK score report that meets the program's language ability requirements. When applying for an English-taught program, an applicant shall provide English proficiency certificate, such as the IELTS or TOEFL test report;

5.Study Experience Resume (The start and end time of each education experience must be uninterrupted, and education level should start from senior middle school);

6.Study or research plan: no less than 800 words in English or Chinese; 7.Two recommendation letters in English or Chinese from two professors or associate professors;

8.Published papers or formal acceptance notification (Compulsory for PhD applicants);

9.An applicant shall submit a photocopy of the Foreigner Physical Examination Form. The medical examinations must cover all the items listed in the Foreigner Physical Examination Form. Incomplete records or those without the signature of the attending physician, the official stamp of the hospital, or a sealed photograph of the applicant are invalid. Medical examination results are valid for only six months;

10.Family financial statement;

11.An applicant shall submit a valid Certificate of Non-Criminal Record (or Police Clearance Certificate) issued by the local public security (such as the police station), usually issued within six months prior to the submission date of the application. 12. 1.Submit CPU Online Application:

From now until February 20, 2023

2.CPU Initial Review and Interview: March, 2023;

*interview schedule will be sent to the application email. Please check your email in time. Applicants who fail to attend the interview are deemed to be giving up the application. 3.Submit CSC Online Application: before March 12, 2023
*CPU will issue the pre-acceptance letter to applicants who pass the CPU interview. Applicants need to submit all application documents and the pre-acceptance letter to CSC Application Platform

4. China Scholarship Council Review:

CPU will deliver materials of applicants who pass the CPU initial review to

CSC and wait for the final admission results;

5.Result Release:

CPU will announce the admission result officially on website or through email;

6.Registration: September, 2023
